



PET CARE AGREEMENT

I/We _____ (hereinafter referred to as “Owner”) have voluntarily employed *Soulful Canine Services (Katarina Wakil)* (hereinafter referred to as “Sitter”) to assist me in the care of my pet(s) _____.

Professional Fees:

Professional fees shall be \$_____ overnight (7pm – 7am) and \$_____ per visit during the day.

Services:

The “Services” consist of the following:

- Feed and water each Pet
- Provide medications for each Pet
- Walk, exercise and play with each Pet
- Clean up and dispose of waste from each Pet
- Any Additional Services specifically listed on Annex A

All food, medication and other supplies to be provided by Owner. To the extent of additional food or supplies are required, Owner will reimburse Sitter for reasonable expenses incurred by Sitter in obtaining such food and supplies. Sitter agrees to provide all Services in a manner consistent with Sitter’s care for Sitter’s own pets.

Location:

Owner and Sitter will agree in advance for the Service Period as to the primary location where the Services will be provided. If any Services will be provided at the Owner’s residence or property owned or controlled by Owner, the following shall apply:

- Services will include returning the residence or property to the Owner at the end of the Service Period in the same state of cleanliness that existed at the start of the Service Period. Sitter is not otherwise responsible for any maintenance, upkeep or cleaning of the residence or property.
- Owner releases and agrees to hold harmless, indemnify and defend Sitter for any claims, damages or loss to the residence or property (or any personal property contained therein) other than to the extent such claims, damages or loss is caused by Sitter’s own gross negligence or willful default.
- While Sitter is not obligated to incur any such expenses. Owner will reimburse Sitter for reasonable expenses incurred by Sitter in dealing with any emergency maintenance or repair issues at the residence or property. Sitter will exercise reasonable efforts to contact Owner before incurring any such expenses. If the residence or property becomes uninhabitable or unsuitable for the provision of Services during the Service Period, Sitter may elect to board each Pet and obtain a substitute location for the provision of Services. Owner shall reimburse Sitter for reasonable expenses incurred in obtaining such substitute location or boarding such Pets.
- Sitter is not responsible for any rent, utilities or other expenses for the residence or property and Owner shall pay or cause to be paid all such expenses

Regardless of the primary location of the Services, Sitter is authorized to take each Pet to other locations that are reasonable suitable for such Pet and to provide transportation for each Pet during the Service Period.

Emergencies:

In the event of a medical emergency involving a Pet, Sitter is authorized to obtain all necessary medical care and Owner will pay or reimburse Sitter for any expenses incurred. Sitter will exercise reasonable efforts to use a Pet's regular provider for such services but shall not be obligated to do so and may use an animal hospital or other provider if reasonably necessary. In the event of a medical or other emergency involving Sitter, Sitter is authorized to place each Pet in a boarding facility selected by Sitter and Owner will pay or reimburse Sitter for any expenses incurred, provided that the Service Period will end upon a Pet being placed in such a facility and Sitter will not be responsible for the care of any Pet placed in such a facility.

Release and Indemnification:

Owner releases and agrees Owner's heirs, assignees and legal representatives will not make claim against, sue, or attack the property of Sitter, her family, acquaintances, or any other person acting on her behalf (herein referred to as "Her Agents"), for damages or losses related to the provision of Services by Sitter, including the death, injury or loss of any Pet and any injuries or property damages caused by the Pet(s) (including injuries to Sitter or damages caused to Sitter's property), in each case other than claims, damages or losses arising solely due to Sitter's own gross negligence or willful default.

Arbitration:

Owner and Sitter hereby agree to mediate and/or arbitrate any misunderstanding that may arise pursuant to the terms contained herein. In any action or proceeding arising out of this agreement, the prevailing party shall be entitled to reimbursement of costs and legal fees

Miscellaneous:

This Contract for Pet Care Agreement supersedes all other agreements, written or oral, previously made between Owner and Sitter.
