



## Puppy Socialization Class Agreement

I/We \_\_\_\_\_ (hereinafter referred to as "Client") have voluntarily employed *Soulful Canine Services (Katarina Wakil)* (hereinafter referred to as "Consultant") to assist me in the socialization class of my pet(s)

### **Professional Fees:**

Professional fees shall be \$40 per puppy for an hour class or otherwise determined by the package purchased.

### **Services:**

The "Services" consist of the following:

- Socializing my puppy with fellow pet classmates, owners, and equipment
- Handling my puppy
- Explaining and teaching some behaviors
- Giving my puppy treats/food

Client acknowledges that socialization/handling/training may be an activity in which damage or injury to dog(s) and/or persons may occur. Client will assume full financial/moral responsibility for the actions of their dog(s). Client further acknowledges that dog(s) may be exposed to a variety of environmental conditions which include, but are not limited to, vehicular travel, interaction with people and other animals, exposure to diseases/viruses/health issues, exposure to adverse weather, and exposure to areas with crowds and all types of traffic.

Socialization is not static; an animal will not continue to perform socialization behaviors or even trained behaviors without ongoing practice. A pet's behavior is ultimately the owner's responsibility. Consultant will make every reasonable effort to help us attain socialization goals but makes no guarantees of performance on the part of Client or pet as a result of providing professional animal training consultation.

### **Release and Indemnification:**

I/We Client agree that I, my/our heirs, assignees and legal representatives will not make claim against, sue, or attack the property of Consultant, her family, acquaintances, or any other person acting on her behalf (herein referred to as "Her Agents"), for injury or damage done to or by dog(s) resulting from action or negligence, however caused, by Consultant or Her Agents. I/We Client forever release Consultant and/or Her Agents from any and all liability and demands which I/We Client, and my/our heirs, assignees and legal representatives may have or may hereafter have for injury or damage to or by dog(s), and assume all risks thereof.

### **No Show Agreement:**

If the Client does not contact the Consultant to cancel at least 24 hours before class, the Client must pay the \$40 class fee. If the Client does not attend the class, the Client must pay the \$40 class fee.

**Arbitration:**

Client and Consultant hereby agree to mediate and/or arbitrate any misunderstanding that may arise pursuant to the terms contained herein. In any action or proceeding arising out of this agreement, the prevailing party shall be entitled to reimbursement of costs and legal fees.

**Miscellaneous:**

This Contract for Puppy Socialization Class Agreement supersedes all other agreements, written or oral, previously made between Owner and Consultant.
